Each restricted stock unit ("RSU") represents a contingent right to receive one share of the Issuer's common stock; vested RSUs are payable in the form of cash, shares of the Issuer's common stock or a combination thereof, except as otherwise indicated below. Dividend equivalent rights accrue with respect to unvested RSUs in the form of additional RSUs ("Dividend Units") when and as dividends are paid on the Issuer's common stock, and Dividend Units vest on the same dates and in the same relative proportions as the RSUs on which they accrue.
- 2. The RSUs vest in four equal annual installments beginning on March 22, 2022.
- 3. The RSUs, which include an aggregate of 211.1935 Dividend Units, vest in four equal annual installments beginning on April 3, 2021.
- 4. The RSUs vest in four equal annual installments beginning on December 15, 2021.
